Following successful completion of the pranapiloga Yoga Teacher Training Program, to become a Registered Yoga Teacher (RYT), I acknowledge that I must register with Yoga Alliance, pay all necessary fees, abide by their ethics and successfully complete continuing education credits as they mandate.

This Agreement will terminate, and all rights granted to me hereby will automatically terminate, upon the first to occur of: (a) my failure to successfully complete the pranapiloga Yoga Teacher Training Program; (b) my failure to comply with any of the terms and conditions of this Agreement; (c) my failure to adhere to the standards established by pranapiloga from time to time for certified pranapiloga Yoga teachers.
